



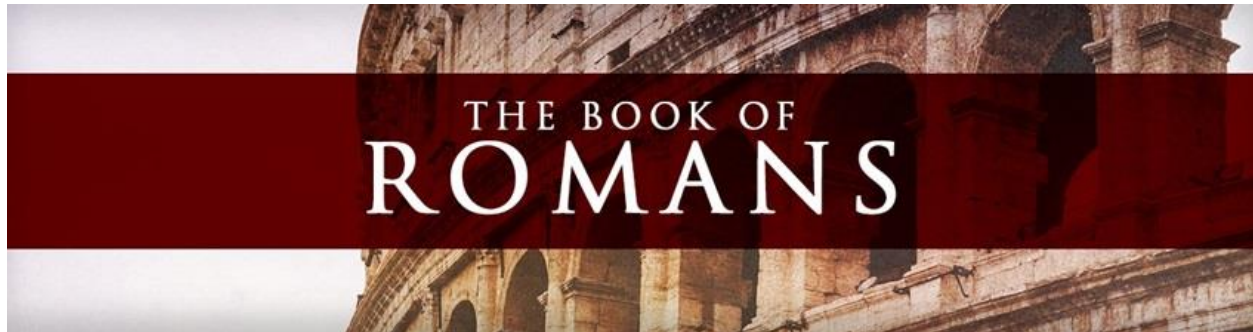
## **My Drift**

Paul emphasizes that God's grace is what makes redemption possible, and that people should pursue Jesus Christ in response.

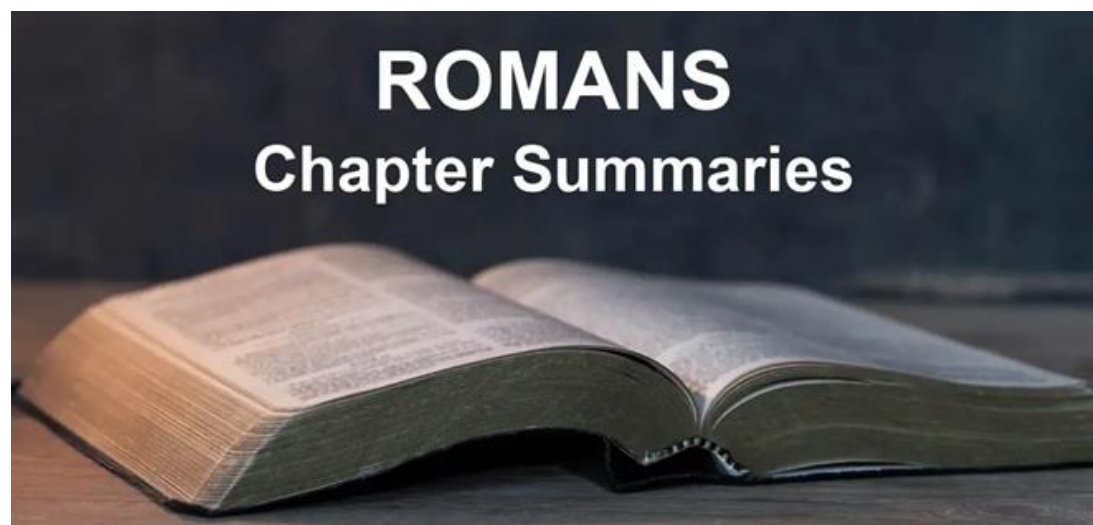
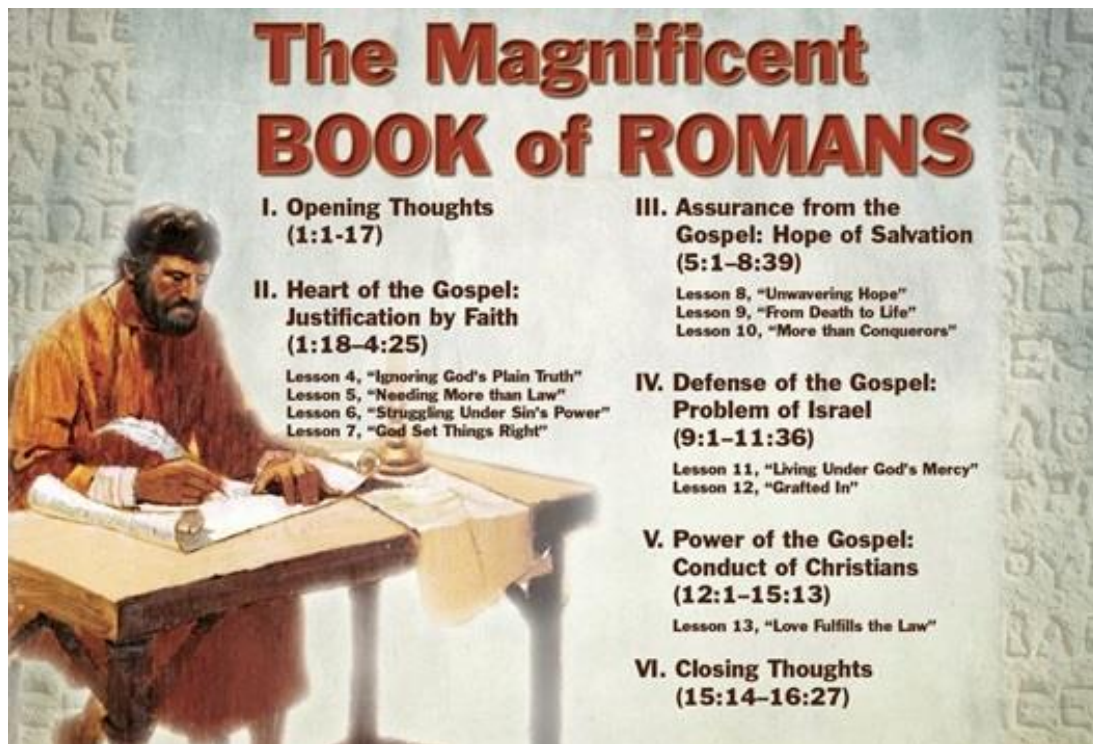
## The book of Romans is divided into four main parts:

Chapters 9-11: Describes how God will not give up on his covenant people

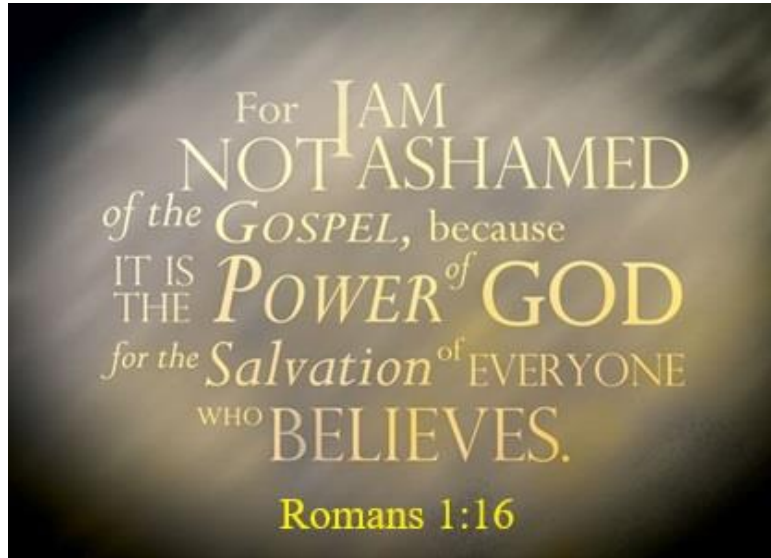
Chapters 12-16: Discusses how love heals and unifies Jesus' family



## Book of Romans Summary by Chapter

### Chapter 1: Introduction and Paul's Calling

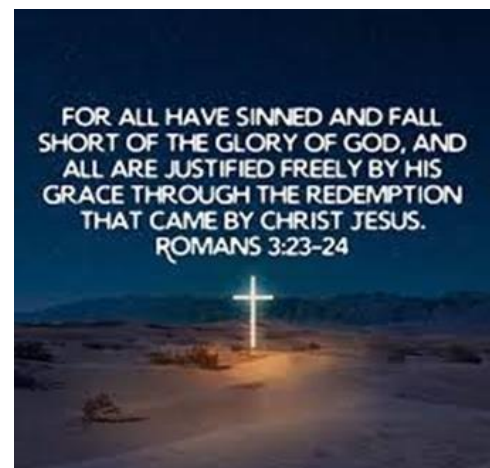


### Chapter 2: Judgment and Hypocrisy

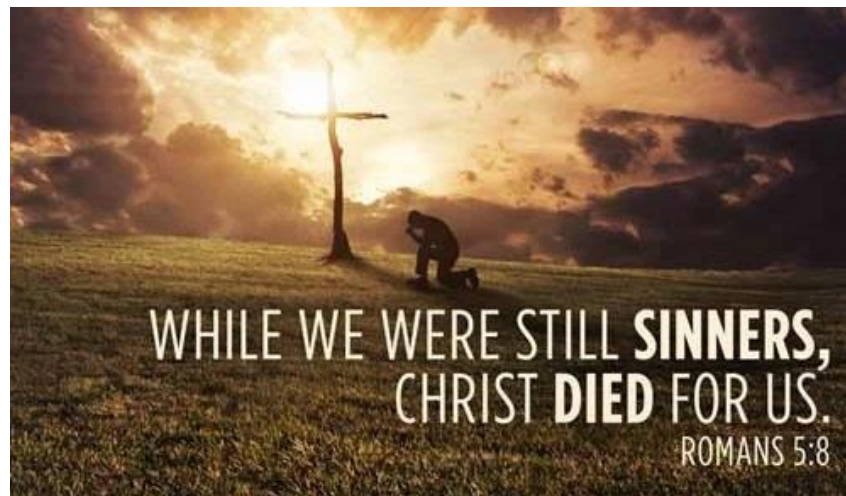


#### **Chapter 4: Abraham as an Example of Faith**

Having been justified by faith, Paul describes the resulting benefits such as peace with God, access to God's grace, and the hope of glory. He explains how suffering in this life can produce perseverance, character, and ultimately hope, through the power of the Holy Spirit dwelling within believers.



#### **Chapter 6: Dead to Sin, Alive in Christ**

Paul addresses the concern of some believers who might view God's grace as a license to sin. He clarifies that, through baptism into Christ's death and resurrection, believers are dead to sin and alive to God. They are no longer slaves to sin but free to live in obedience to God.

#### **Chapter 7: The Struggle Between Law and Sin**

Using an analogy of the law and marriage, Paul describes the struggle between the desires of the flesh and the demands of the Law. He acknowledges the limitations of the Law in providing freedom from sin and highlights the need for the Holy Spirit's power to empower believers to live righteously.

#### **Chapter 8: Freedom in Christ and the Hope of Glory**

Through the power of the Holy Spirit, Paul assures believers that they are free from condemnation and empowered to live according to the Spirit, not the flesh.

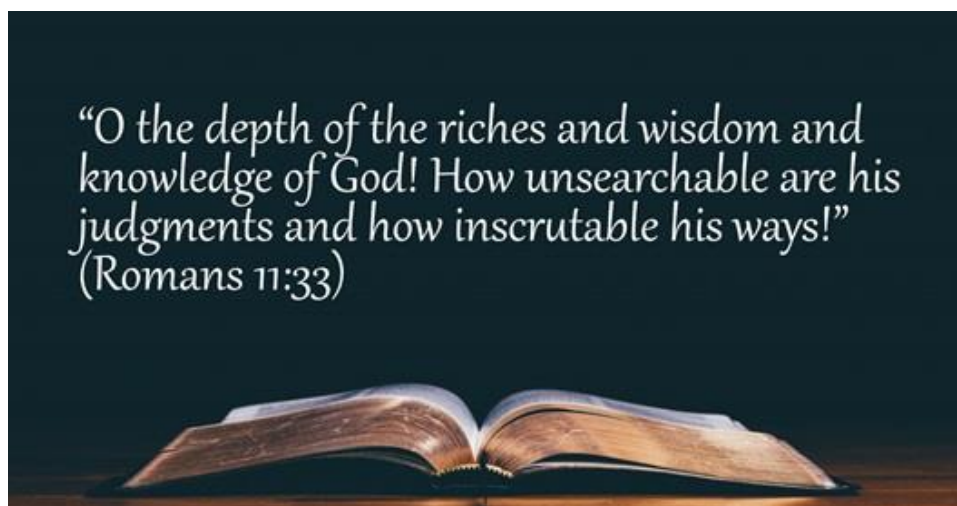
### **Chapter 10: Israel's Stumbling and the Righteousness of Faith**

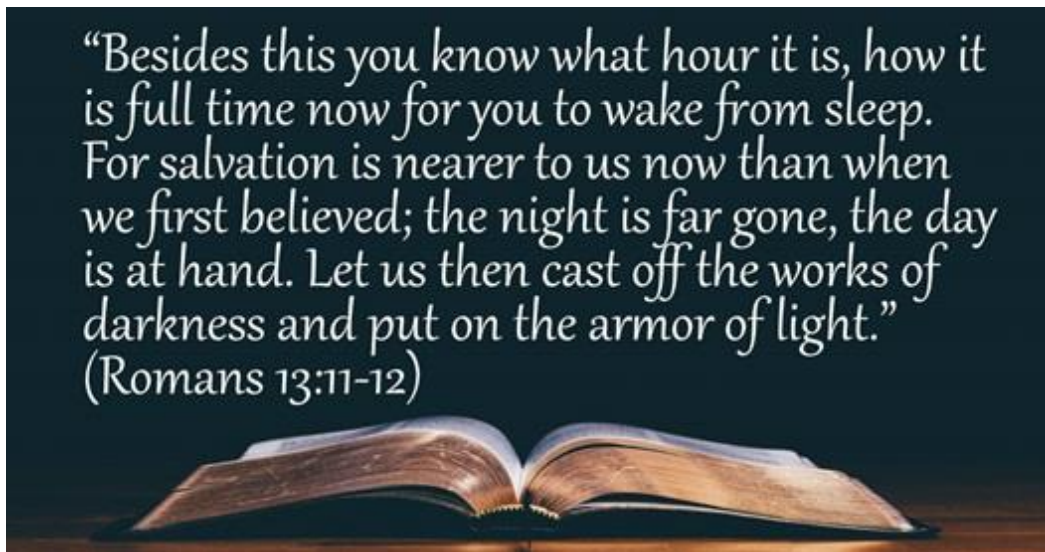
## **Chapter 12: Living Sacrifices and Spiritual Gifts**

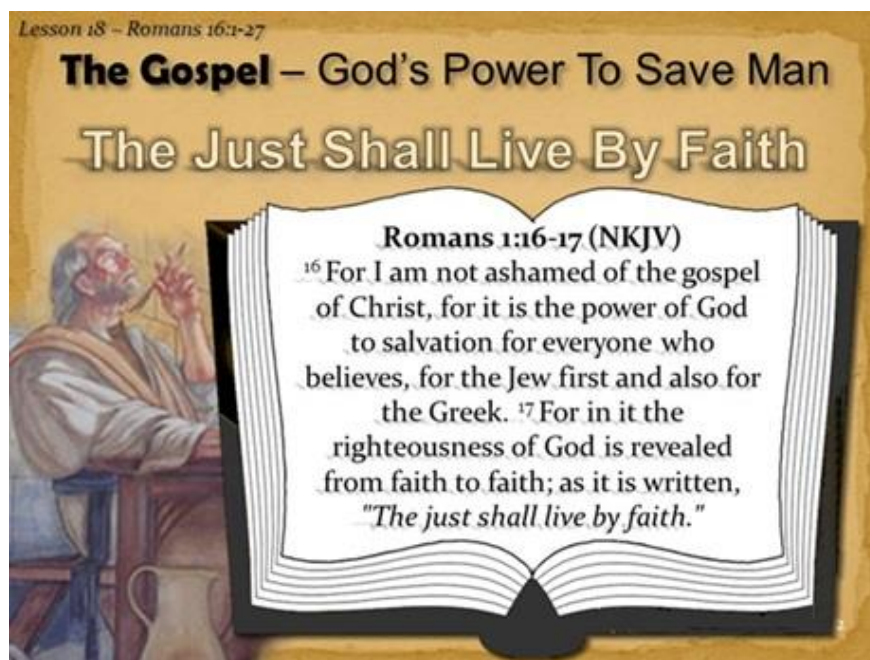
## Chapter 15: Encouragement for Unity and Paul's Ministry Plans
